

Corporate Volunteer Risk Assessment Guidelines 2020

We are happy for you to use the following information to carry out a risk assessment of our site, but would like to make it clear that these are guidance notes only.

Responsibility for carrying out a full risk assessment for your group's visit to Marwell Wildlife remains within the group and under no circumstances should these notes be used in place of that assessment.

Fire Evacuation Procedure

- In the event of a fire the fire alarm will sound or a member of staff will advise
- Exit the building you are located in by the nearest door and head for the closest fire evacuation point.
- Please assist our staff by following their guidance and keeping your group calm
- You are responsible for keeping your group together and for a head count once at the fire evacuation point.

Accident Procedure

- If you require first aid please contact any member of staff including catering staff
- We always have a team of first aiders available
- We are obliged under Health & Safety law to ensure an incident form is completed.
