Feathers	All	Feather allergy	2	2	4	Written instructions advise not to touch if you have an allergy. Teachers should be aware of children's allergies in own risk assessments for trips.			
Props with thin ends, e.g. feathers and sticks, cheetah spine, hair clip	Children	Poking eyes with thin ends	2	2	4	Adult supervision by visiting group leader. Written instructions to keep away from eyes. Cheetah spine prop has rubber over wire with 2cm at each end folded over and taped.

Risk Assessment

Props with sharp ends, e.g. Glove with claws, sticks	Children	Scratch with sharp ends, poking in eyes.	2	1	2	Adult supervision.
Props that can pinch / squash, e.g. hair clip and nut cracker	All	Pinching, crushing of fingers	2	2	4	Adult supervision. Cable tie to keep nutcracker closed.
Props that look like food	Children	Eating the plastic fruit and leaves, etc	2	1	2	Instructions say it is plastic. Adult supervision.
Props with sharp edges, e.g. anchovy can	All	Cut on sharp edge	1	1	1	Ring pull taped down to prevent opening. Adult supervision.
Props being used inappropriately, e.g. magnifying glass	Children	Blinding if looking at sun. Hit themselves or each other with props.	3	2	6	Adult supervision.
Slipping on props or uneven surface	Children	Tripping/slipping	1	1	1	Instructions to use smooth floor/ground with space around, and supervision. Clear any trip hazards first. Props designed for standing on are non-slip.
Running on spot activity	Children with pre- existing medical conditions	Illness caused by running with pre-existing condition	2	3	6	Warning on teacher instructions; trained First Aiders on site.
Desert sensory box	children	Abrasion injury from sandpaper	3	1	4	Adult supervision

Likelihood (L) = Frequent(5) - Probable(4) - Occasional(3) - Improbable(2) -

Severity of Risk (SR) = (L) LIKELIHOOD x (S) SEVERITY

Severity: (S) = Catastrophic(5) - Major(4) - Reportable(3) - Serious(2) - Minor(1)

For more detailed information on how to calculate the **Severity of Risk** (SR) see explanation below and the supporting "**Attached Information**" document. Where the **Severity of Risk*** score (found in column **SR***) is above 10 (blue blocks) you must advise your Line Manager so that appropriate corrective action can be taken to reduce the risk level. If the score is above 16 (**red blocks**) STOP the activity and refer **IMMEDIATELY** to the H&S Manager and your Line Manager to decide on the corrective action necessary.
